LIFEGUARD FEE

I understand that Lifeguards are **Strongly Suggested** for any pool reservation, swimming and non-swimming. This reservation does **NOT** include the cost of lifeguards. I also understand that I am responsible for the negotiation and payment to a lifeguard for my reserved date and time. Lifeguards, if contracted, must be present from the start of your reserved time to the end of your party, including clean up time. The lifeguards are the last ones to leave the pool premises. Depending on the size of your event the Meadowbrook Recreation Association, reserves the right to require Lifeguards (at your cost) to be on duty during the event.

CLEAN UP PROCEDURES I understand that given the nature of Pool Parties, the Member is required to clean up the pool area. The Board of Directors reserves the final determination of cleaning fees required based on scope of your reservation.

Required cleanup:

1. Throw away all trash on tables, chairs, and pool area.
2. Empty all trashcans and remove trash with you from the pool area.
3. Return pool furniture to proper locations (as found at start of your reservation).
4. All personal items (kegs, food trays, stereo, etc.) must be removed from the premises.

I / we, _____ Accept full responsibility for use of the Meadowbrook Pool Area. I agree to return the facilities to the same condition it was upon use, including removal of trash from the premises. I agree to pay for the repair of any damage to the building, furniture or any facilities in the Meadowbrook Pool Area occurring during the time of my use of the facilities. I agree to pay to have the Meadowbrook Pool Area cleaned if it is not left in the same condition it was upon my use. I agree to pay the cost of all repairs or cleaning that the Board of Directors may assess me. If this amount is not paid within thirty days, I further agree to return my membership and have those costs subtracted from my Pool deposit. I fully agree to abide by all the Rules and Regulations of the Meadowbrook Pool and will take responsibility for the actions of my guests. I will not engage a band. No musical amplifiers are allowed. I will keep all noise associated with the party at a reasonable level and understand that the Napa County Noise Ordinance is in effect 24 hrs. a day. I agree to comply with all applicable Federal, State and Local Laws and Ordinances in effect. The front gate will be closed and locked at all times, even after all guests have arrived.

GENERAL RULES TO BE FOLLOWED: -

1. No Smoking is allowed in the Meadowbrook Pool Area.
2. No alcohol inside the Meadowbrook Pool gated area.
3. All trash will be removed from the premises. No trash can be set in front of the Meadowbrook Pool Area.
4. When reserving the pool, a lifeguard(s) should be retained at your own cost or as required by the Board of Directors (based on the size of the party).
5. **An adult MUST be present inside the Meadowbrook Pool gated area at all times while swimmers are present.**

I agree to be personally in attendance at the pool facilities at all times during the term of the activity associated with this Agreement. I agree that if any of the foregoing rules, regulations, terms or conditions are disregarded by me or my guests, my Meadowbrook Pool deposit may be forfeited and I may lose the ability to use the pool at any future date.

In the event of my breach of this Agreement, I agree to be responsible for any court costs, and other expenses, including reasonable attorney's fees incurred by Meadowbrook Pool Board of Directors for the collection of any charges under this Agreement or for the enforcement of any terms of this Agreement. For and in consideration of my use of The Meadowbrook Pool Area, I assume all risks and hazards incidental to the use of the pool facility, and on behalf of myself and my guests, do hereby indemnify, release, and hold harmless The Meadowbrook Pool Board of Directors, Property Managers, Employees, Agents and the Meadowbrook Recreation Association, et al. from all claims and causes of action of any kind what so ever which may arise or hereafter accrue in connection with my reservation or use of The Meadowbrook Pool facilities, including but not limited to the loss, damage or theft of personal property placed in or near the facilities.
